COMMENCEMENT OF CIVIL LITIGATION UNDER RSMO 610.027; SETTING ASIDE PURCHASE OF GRANBY POLICE STATION FROM STYRONS UNDER RSMO 610.027.5; PETITION FOR WRIT/INJUNCTION AGAINST SPENDING GRANBY CEMETERY TRUST FUNDS; AND INJUNCTION / PETITION FOR WRIT OF PROHIBITION ORDER AGAINST JUDGES KEVIN LEE SELBY, GREG STREMEL AND CHARLES CURLESS UNDER RSMO 610.030

COMES NOW the Plaintiff(s)/Petitioner(s) Pastor Martin Luther Dzerzhinsky Lindstedt, of the Church of Jesus Christ Christian / Aryan Nations of Missouri, The Ten Thousand Warlords Political Action Committee, and the sub-corporation Newton County Geldings & Walking Wombs – as an aggrieved party having standing under provision of Revised Missouri Statutes (RSMo) 610.027 to pursue this action before this Circuit Court concerning the violation(s) of the Missouri Sunshine Act and to gain an injunction / Writ of Prohibition against the corrupt judges Kevin Lee Selby, Gregory Stremel and Charles Curless without jurisdiction from further enforcing under color of law a perjurous Ex Parte “Domestic Assault” actions brought by Granby City Clerk Lawna Cherice Price and

Granby City Collector Carra Jo Coffey designed to violate the First Amendment “privileges” to criticize them and the rest of the Granby Municipal regime criminals for their manifest corruption. It is clear that this criminal misconduct is encouraged by all the Granby Municipal Defendants, drawn up by City Attorney Jared Thomas, and given a surface legality by Judge Kevin Lee Selby. The injunction / Writ of Prohibition sought under RSMo 610.030 will not be necessary if these judges Kevin Lee Selby, Gregory Stremel and Charles Curless admit that they do not have jurisdiction under RSMo Chapter 455 – Domestic Relations – and will summarily cease usurping / “assuming” jurisdiction to abuse granting these fraudulent ex parte orders to crooked Granby City “workers” who are ridiculed when they refuse to obey the provisions of the Missouri Sunshine Law, and when these Sunshine Law lawsuits are prosecuted by Pastor Lindstedt instead punish and instead seek to silence Lindstedt through malicious prosecution and abuse of legal process.

By abusing the Missouri Sunshine Law and using their made-up powers to make up municipal ordinances like #815 seeking to criminalize dissent and negate questions and by abusing these fraudulent “domestic protection orders” to negate knowledge of cemetery board meetings these city council members, the mayor, the police, the city hall workers have been able to buy property from the Styrons for \$200,000 plus \$70-100,000 interest for their “new” police station as opposed to fixing their old police station roof for several thousand or buying an adjacent property to Granby City Hall for \$21,000. Even more recently, the City of Granby conspired to get into a Granby Cemetery Trust Fund worth \$250,000 by means of appointing a cemetery board which would spend it without allowing Pastor Lindstedt notice of their Cemetery Board Meetings. Wherefore, Pastor Lindstedt seeks to set aside these corrupt machinations using the provisions of RSMo 610.027.5 and set aside the contract to purchase the “new police station” from the Styrons and to restore the Granby Cemetery Fund to the \$250,000 it had before it was looted.

Likewise, the “Honorable” Associate Circuit Court Judge Kevin Lee Selby, Circuit Court Judge Gregory Stremel should stop “assuming” jurisdiction to create these fraudulent and perjury-based ex-parte ORDERS concerning “domestic violence” where none such exists in order to protect corrupt city workers from ridicule. Likewise visiting

Judge Charles Curless should be forbidden from granting summary judgment on behalf of the City of Granby for two previous Sunshine Law Enforcement Actions, Lindstedt v. City of Granby, et.al, 18NW-CV00601 and 18NW-CV00812 in violation of law and of punishing Pastor Lindstedt for daring to sue Granby by granting \$4000 “sanctions” to Granby’s jew lawyer Todd Brian Goldstein.

SUGGESTONS OF FACT AND LAW

1. The Granby City Council always intended to get the voters of Granby to buy them a “new” police station instead of fixing the roof of their old police station, so they promised to build a \$1 million new police station and have FEMA pay for 90% of it and finance it through a ¼ cent sales tax bringing in less than \$25,000 per year. When Pastor Lindstedt running for mayor against T. Rampage Gamble pointed out that this would mean paying 40 years to pay it off not counting interest and pointed out it would be cheaper to fix the old police station roof or buy the old Rex Burnett grocery and Laundromat next door to City Hall for \$30,000, Mayor Gamble refused to even consider these options. (In March 2018 Pastor Lindstedt found out that the Rex Burnett store building sold for \$21,000 to Jaimie Arnall, who left it open to purchase for eight months and after the sales tax passed before she bought it upon City Council refusal.) It is now understood that the Granby City Council all along intended to buy the Styron “Tree House” property further up Main Street for \$270,000 to \$300,000 instead of building a “new” police station as promised, fixing the roof of the old police station, or buying for \$21,000 the building next door.

2. Pastor Lindstedt had litigation scheduled for 23 January 2018 in Lake County Ohio, 900 miles away. But the Lake County Court decided to postpone the trial and so Pastor Lindstedt went down Friday, January 19, 2018 to get the “City Council packets” for the 23 Jan. 2018 city council meeting that afternoon, not telling them that the Lake County trial had been cancelled. Pastor Lindstedt was handed an agenda sheet and council packets not mentioning that they intended to take advantage of Lindstedt’s absence to vote on a contract signed Jan. 18th by Mayor Gamble to buy the Styron property for \$200,000 plus another \$100,000 interest payable by decades of \$1500 monthly payments

from the City ¼ cent sales tax. If an amended agenda sheet was posted Friday, it must have been posted soon after Pastor Lindstedt received the deceitful agenda and packets.

3. At the City Council Meeting there was a totally different agenda which was aimed at purchasing the Styron property. Pastor Lindstedt posted a video which can be seen The video can be seen – entitled “Granby City Hall Raw Footage 23Jan18” --

In this raw unedited footage there is much deceit as to when this new modified agenda was posted with Mayor Travis Rampage Gamble, City Clerk Lawna Price and City Collector Carra Jo Coffey making up stories as to when this modified agenda and proposed contracts were posted according to law. After around 40 minutes Pastor Lindstedt was arrested under color of Granby City Ordinance #815 and they passed the ordinance buying their “new” police station from the Styrons as planned all along.

4. The entire Granby City Council has authorized their city employees Lawna Price and Carra Coffey and their City Attorney Jared Thomas to fraudulently pursue an ex parte action for domestic abuse under RSMo Chapter 455 – Domestic Relations – in order to get around Pastor Lindstedt having First Amendment privileges to criticize Granby corrupt government and the Missouri Sunshine Act. This behavior is also a criminal conspiracy as defined by 18 U.S.C. § 241, 242 – Conspiracy to violate civil rights and Deprivation of civil rights punishable by up to ten years in prison. These fraudulent “domestic protection orders” sought out and signed by Judges Kevin Lee Selby and Gregory Stremel have been used to keep Pastor Lindstedt from finding out Granby civic business in order to keep them from looting the Police, the TIF, the Buildings and Parks, and now the Cemetery Trust funds.

5. An injunction is sought under RSMo 610.030 against Judge Kevin Lee Selby and Gregory Stremel as a Writ of Prohibition against these corrupt judges usurping jurisdiction by granting an ex parte ORDERS of Protection against Pastor Lindstedt by Granby municipal employees and officials in an effort to get around the Missouri Sunshine Law. This injunction is also sought against visiting Judge Charles Curless for corruptly dismissing two previous Sunshine Act enforcement actions. Since Pastor Lindstedt has been deprived of First Amendment paper protections for seeking Sunshine

Law enforcement against Granby Defendants, then in reality there is no real meaning behind the Missouri Sunshine Law – or the First Amendment for that matter.

6. The Granby City Council and City Clerk Lawna Price abused their fraudulent “domestic protection orders” in order to justify posting Notices of Meetings of the Granby Cemetery Board after Pastor Lindstedt left City Hall on Mondays, Wednesdays, and Fridays from 1-2 pm under the fraudulent restrictions imposed by these treasonous ORDERS signed by these corrupt judges sans jurisdiction and then presenting Pastor Lindstedt with a fait accompli when these Cemetery Board meetings end with resolutions to get their mangy thieving mitts on a quarter-million dollars desposited into a Cemetery Trust Fund established since 1960. In short the Granby City Council has conspired to steal a quarter-million dollars deposited in good faith for the overall good of a cemetery for their dearly departed. There isn’t a single fund in Granby that hasn’t been looted.

7. Pastor Lindstedt asks that due to these violations of the Missouri Sunshine Law that the purchase of the Styron property on 23 Jan 2018 for roughly \$300,000 (and counting) be set aside under provision of RSMo 610.027.5 and all funds paid be refunded by the Styrons and this fraudulent contract nullified. Also, that the Granby Cemetery Trust Fund be sequestered by this court and that Granby City resolutions to allow their picked Cemetery Board members to spend any part of the Cemetery Trust fund be revoked until this thievery can be sorted out.

8. Due to the chronic corruption of the Newton County judges, yet cases based upon these Sunshine Law violations are to be tried in the county, Pastor Lindstedt demands trial by jury as opposed to a bench trial given that the judges involved are biased and have interests in this matter.

Wherefore Plaintiff Pastor Lindstedt upon commencing this action under the Missouri Sunshine Law asks for trial by jury as soon as possible as well as an injunction / Writ of Prohibition against Judges Kevin Lee Selby and Gregory Stremel issuing fraudulent restraining orders against Pastor Martin Lindstedt receiving public documents and attending public meetings wherein these corrupt and perjurous City of Granby Officials and employees choose to hold such open public meetings, that said “domestic

protection orders” be set permanently as abusive to the letter and spirit of the Missouri Sunshine Act and First Amendment. That the contract for the sale of the Styron property for the “new” Granby police station be set aside and that the Cemetery Trust Fund be taken out of the hands of the City Council picked Granby Cemetery Board. That any funds spent be replaced. And that Pastor Lindstedt’s two previous Sunshine Act Enforcement Actions, Lindstedt v. City of Granby, et.al., 18NW-CV00601 and 18NW-CV00812 be restored to trial by jury before a different judge out of this circuit other than the extremely corrupt judge Charles Curless.
