## REQUEST FOR RESTRAINING ORDER AGAINST CITY OF GRANBY DEFENDANTS FROM SPENDING CITY FUNDS ON STYRON PROPERTY UNTIL THIS CASE IS DECIDED

COMES NOW the Plaintiff(s)/Petitioner(s) Pastor Martin Luther Dzerzhinsky
Lindstedt, of the Church of Jesus Christ Christian / Aryan Nations of Missouri, The Ten
Thousand Warlords Political Action Committee, and the sub-corporation Newton County
Geldings & Walking Wombs – to Request a Restraining ORDER against City of Granby
Defendants from spending city funds (taxes or from police or general tax funds) on
purchasing the Old Styron Building and/or in spending additional funds prior to the
determination under this Sunshine Act Enforcement Action as to whether this purchase
will or will not be voided under provision of Revised Statutes of Missouri (RSMo)
610.027.5 and all funds paid be refunded by the Styrons and this fraudulent contract
nullified.

At the 28 May 2019 Granby City Council meeting the current City Council voted to spend \$2200 on construction materials to put the Granby Municipal Court in the "new" Granby Police Station as opposed to holding their cash-register proceedings in City Hall like since forever. When reminded that there is supposed to be a dismissal hearing on 7 June 2019 over this Sunshine Act Enforcement Action the current City Council proceeded anyway, as noted by their Minutes of 28<sup>th</sup> May. Therefore the fix is in as to this case or the Granby City Council is acting recklessly in spending money on a building whose shady purchase is the cause for this litigation. Police Chief Jacob Kelley has told Plaintiff twice that never in the history of this law pretending to transparency and public

accountability has a governmental unit been forced to disgorge its transactions achieved through fraud. That may well be, but Granby doesn't need a municipal police department or municipal court, indeed Granby should be dis-incorporated and its citizenry should refuse to co-operate with the City authorities and make it impossible for their police department be anything other than a drain on City funds until Granby is bankrupt.

Furthermore, Granby is spending \$1500 per month on a purchase price of \$200,000 plus \$53,643.23 through to May 2032. There could have been a purchase of the old Rex Burnett grocery and laundromat for \$30,000 next door to City Hall instead of letting it go for \$21,000 to Jaime Arnall for her sewing shop. Mrs. Arnall told me again last week that the current Mayor Ira Hawkins told the realtor that under no circumstances three or four months after the People of Granby were conned into voting for a ¼ cent sales tax for a "new" police station would they buy that property she left open so she got it for what the realtor had in it, \$21,000. The fix was in to not only buy the Styrons a new store for \$250,000 for their Dollar General Store, but to sell their old store – The Tree House – once they couldn't get cheap Chinese sweatshop textiles to stock. So the People of Granby have had funnelled \$600,000 in tax money to support the Styrons based upon their control of the Granby City Council over the past decade or two.

In the past few months the former mayor Travis Rampage Gamble has been forced to resign and property on US Route 60 has been offered for sale at \$20,000. A used trailor house from the public schools is available for \$9,000 and moving it costs \$3000. A "new" police station could be made of concrete blocks on that \$20,000 property. In short there is no need to keep on spending money in graft and kickbacks if a "new" police station is necessary. There is no need to waste further money on the Styron purchase and then claim that since so much money was poured down that rathole that regardless of the corruption involved that the continuing purchase costing the remainder of \$200,000 continue instead of negating this corrupt deal under provision of RSMo 610.027.5

Wherefore, Plaintiff requests a Temporary Restraining ORDER or Injunction against the City of Granby Defendants spending money on construction or remoldeling the old Styron Building used as a "new" police station and/or in paying \$1500 per month to the Styrons to purchase their old building until such time as this Sunshine Act Enforcement litigation is settled under provision of RSMo 610.027.5. Plaintiff shall draft up a proposed ORDER.
